VOLUNTARY ANNOUNCEMENT INVESTMENT IN A LIMITED PARTNERSHIP

Weimob Yunbing participated in Nanjing Meridian Weimob Fund through its commitment to subscribe for RMB50,000,000 in Changshu Weimob as a limited partner of Changshu Weimob, representing 50.0% of the total subscribed capital contribution of Changshu Weimob. Neither Changshu Weimob nor Nanjing Meridian Weimob Fund will become a subsidiary of the Company.

Nanjing Jianye Technology Innovation Fund is a company incorporated in the PRC with limited liability and is principally engaged in equity investment and investment management. Nanjing Jianye Technology Innovation Fund is a fund for guiding technology innovation industry established by Nanjing Jianye District Finance Bureau.
